#### What data is collected?

We collect:

- **Identification data:** first name, last name
- **Contact data:** email,
- **Geolocation data:** province or state
- **Any other information that you voluntarily share with us.**

#### Why do we collect this data?

The personal data collected is used for your consent to subscribe to our newsletter.

#### Who is the data controller?
